ANTICIPATED GOVERNMENT RESPONSE TO NDIS REVIEW AND DRC RECOMMENDATIONS

The disability sector eagerly awaited the government's response to the NDIS review and Disability Royal Commission (DRC) recommendations released last year. However, the full government response, initially expected in March 2024, has been delayed and is now anticipated later in the year when the Federal parliament reconvenes in June.

Interestingly, just before the Easter break, Hon Minister Bill Shorten tabled a new bill, the National Disability Insurance Scheme Amendment (Getting the NDIS Back on Track No. 1) Bill 2024. For a summary, you can visit the following link: https://teamdsc.com.au/resources/new-ndis-legislation

MEDICARE URGENT CARE CLINICS NOW OPEN ACROSS AUSTRALIA



Let's applaud Adriana - our Hero of the Month - for her exceptional dedication and impact within our community!




IDS HERO TEAM
